ORDINANCE NUMBER TWENTY-ONE

AN ORDINANCE PERTAINING TO RULES AND REGULATIONS OF THE CITY DUMP AND PROVIDING PENALTIES FOR VIOLATIONS OF SAID ORDINANCE.

THE CITY OF CARSON CITY ORDAINS:

The dumping ground on the northwest side of the City, owned by the people of the City, is hereby declared to be under the direct supervision of the City Engineer, working through a City Dump Director, who shall be appointed by the Council.

The dump shall be open, at such hours as shall be determined and posted by the City Engineer, to the residents of the City of Carson City and any residents of any township which is on a stand-by basis providing the stand-by fee has been paid.

Entry onto the dump grounds for the purpose of dumping at any time other than during the hours as posted shall constitute a violation of this Ordinance. No person, other than the Dump Director, shall engage in any scavenger or so-called "dump picking" activity, on or at the dump premises.

Violation of this Ordinance shall constitute a misdemeanor punishable by a fine not to exceed one hundred (\$100.00) dollars and imprisonment in the county jail not to exceed ninety (90) days, or both such fine and imprisonment.

This Ordinance shall be effective commencing January 1,1963.

Passed and approved December 18, 1962.

AMENDMENT TO ORDINANCE 21

THE CITY OF CARSON CITY ORDAINS:

Ordinance No. 21 is hereby amended by adding SECTION II as follows:

SECTION II. a. It is the general duty of the City Engineer, in addition to the duties set forth in Ordinance No. 21 as passed on December 18, 1962, to plan, determine and regulate the uses to be made of the City Dump in order to provide for its orderly and systematic operation so that its use will not endanger the safety and general welfare of the community, will not create a nuisance to the community and so that the smoke, odor and noise therefrom shall not be unreasonable.

- b. In performing the duties set forth in Section IIa, the City Engineer shall have the authority to:
 - 1. Designate specific areas of the City Dump for the disposal of specific types of rubbish, refuse or waste materials.
 - 2. Require that rubbish, refuse and waste be separated into reasonable classifications for disposal in specific areas of the City Dump.
 - 3. Prohibit and permit use of specific areas of the Dump as may be necessary.
 - 4. Prohibit and permit the disposal of any and all rubbish, refuse and waste material as may be necessary.
 - 5. Adopt any and all other reasonable regulations necessary to carry out the provisions of Section IIa.
- C. The authority to plan, determine and regulate the City Dump contained in this Ordinance shall be exercised by the City Engineer by the issuance of dump control orders which shall specify the regulations adopted by him. Such dump control orders shall become effective upon being filed with the Comptroller and upon erection of adequate signs in the dump, giving notice of the existence of such regulations. Dump control orders may be issued by the City Engineer on his own authority but when so issued shall be known as temporary dump control orders and shall not be effective after the expiration of 90 days from the date of filing, nor shall any such temporary dump control order

be renewed or extended except upon its approval by the City Council. Permanent dump control orders shall be issued by the City Engineer, approved by the City Council and filed with the Comptroller. Temporary orders shall become permanent orders upon approval by the City Council, but notice of such approval shall be filed with the Clerk as in the case of an original dump control order. All such orders and any action modifying or repealing such orders, shall be kept in a separate book by the Comptroller to be known as the dump control order book.

d. This Amendment to Ordinance No. 21 shall take effect and be in force from and after January 2, 1966.
