

ORDINANCE NUMBER SIXTY-FIVE

AN ORDINANCE OF THE CITY OF CARSON CITY CONSISTENT WITH AND PRUSUANT TO SECTION 6.1 OF THE MICHIGAN REGULATION AND TAXATION OF MARIHUANA ACT.

CHAPTER 65. 1

SHORT TITLE

CITY OF CARSON CITY – ORDINANCE HAVING THE REGULATORY EFFECT OF PROHIBITING MARIHUANA ESTABLISHMENTS, WHICH MAY BE COMMONLY REFERED TO AS OPTING OUT OF THE MICHIGAN REGULATION AND TAXATION OF MARIHUANA ACT.

CHAPTER 65. 2

PROHIBITION

That pursuant to the Section 6.1 of Michigan Regulation and Taxation of Marihuana Act, the City of Carson City elects to prohibit and make unlawful any marijuana establishment or facility that is operated for profit or not for profit from operating within boundaries and Jurisdiction of the City of Carson City.

CHAPTER 65.3

CONFLICTING ORDINANCES AND AMENDMENTS SUPERSEDED

Any City ordinance and/or amendments thereto or resolutions that are in conflict or parts thereof which conflict with any terms of this ordinance are hereby rescinded. In case of conflict between this ordinance and any such ordinances or resolutions, this ordinance shall control. The catch line headings which precede each section or subsection of the ordinance are for convenience and reference only and shall not be taken into consideration of any construction or interpretation of any of the provisions of this ordinance.

CHAPTER 65. 4

PENALTIES

Any person and/or business or business entity in violation of this Ordinance, shall be pursuant to the penalties as set in the applicable and appropriate Sections of Michigan Complied Laws.

CHAPTER 65. 5

EFFECTIVE DATE

This Ordinance shall become effective 10 days after publication in full in the Carson City Gazette being a local newspaper of general circulation as set forth in Chapter 7.3 of the City Charter of the City of Carson City.


CHAPTER 65.6
